The campaign featured a story and video about renowned Chef Chris Aerni of The Rossmount Inn in Saint Andrews, New Brunswick and how he is inspired by farmed Atlantic salmon as well as an interview with Dr. Steve Backman, one of the pioneers of Atlantic Canada's aquaculture sector.





REGULATORY AFFAIRS AND FARMING OPERATIONS

New Brunswick Aquaculture Regulations and Aquaculture Growth Strategy

ACFFA producers were engaged early in the development of a new Aquaculture Growth Strategy for New Brunswick. This strategy is being drafted at the same time as the new aquaculture regulations. The two documents will frame the path forward for aquaculture growth in New Brunswick. We anticipate both documents will undergo a final consultation before being finalized in early 2022.

Atlantic Finfish Aquaculture Working Group

This working group that ACFFA co-chaired in the region with DFO between 2016-2020 has been re-established. The committee provides a forum for industry, provincial and DFO discussions on priorities for the sector in Atlantic Canada.

NB Industry Government Working Group and the Aquaculture Environmental Coordination Committee

These two committees were merged in 2020. As land-based systems including post smolt and hatcheries expand, it is important that the Department of Environment is at the table for all discussions as they are the lead regulator for freshwater in New Brunswick.

Atlantic Ministers Renew the Aquaculture Sustainable Development MOU

The Atlantic Ministers responsible for aquaculture renewed an Atlantic Aquaculture MOU. Leading into that, the Associations in the region called on the Premiers and Ministers to develop a common vision for the growth of the industry as well. Their cohesive support of the industry in Atlantic Canada plays a key role in the sector's management and growth.

REGULATORY AFFAIRS AND FARMING OPERATIONS

Marine Protection Areas (MPAs)

The Southwest Fundy Progressive Protection Council is working with DFO to complete a non-spatial conservation document and story map for the Bay of Fundy. This will complement the work the Council is doing by highlighting marine activities that can be considered as conservation methods and recognized in lieu of an MPA. This list includes the Fundy Salmon Recovery project and the Wild Salmon Conservation Farm.

Marine Debris Strategy Action Committee (MDSAC)

We continue to be participants in the Marine Debris Strategy Action Committee (MDSAC) which guides the development of a marine debris strategy in southwest New Brunswick. This multi-stakeholder committee is comprised of traditional fisher associations, aquaculture, nongovernmental organizations, First Nation groups, harbour authorities, academic representatives, federal and provincial government. This committee's #DebrisFreeFundy project is making great strides at keeping debris like rope and plastic out of the Bay of Fundy.

Aquaculture Diver Adhoc Committee

An Aquaculture Working Group via CSA met for the first time in 2021. This group was a result of ACFFA facilitating an Adhoc Committee ensuring the CSA acknowledged all forms of diving for the industry across Canada.

Annual Research, Science and Technology Forum

As a result of the COVID-19 pandemic, ACFFA's annual Research, Science and Technology Forum went virtual in 2020. Our two-day virtual event brought together 230 aquaculture professionals, researchers, regulators and other stakeholders to share the latest leading-edge research and innovations from the aquaculture sector.

Fundy Salmon Recovery

COVID 19 changed how all the partners in the Fundy Salmon Recovery (FSR) project celebrated the release of adult wild salmon back to their rivers from the conservation farm on Grand Manan in 2020 but it didn't stop the good news. Almost 1,400 salmon were released to the Upper Salmon, Point Wolfe and Pollett Rivers in the fall and over 40 returning salmon were observed in the rivers from the 2019 FSR releases in 2020. Fundy National Park saw a large smolt run in the spring of 2021, released over 700 salmon in September, and detected over 100 salmon return to their rivers from the 2019 and 2020 releases. The Fort Folly Habitat Recovery team saw over 30 salmon return to the Pollett River from the 2019 and 2020 release of FSR project salmon.


Woodwards Cove Wharf

Infrastructure priorities remain focused on ensuring we have access to safe wharves. We have secured Fisheries and Oceans funds to support the next step in rebuilding the wharf at Woodwards Cove, Grand Manan. ACFFA co-chairs the Woodwards Cove Wharf project committee with DFO which is progressing to complete the coastal study portion.

Limekiln Bay Service Centre

Our Wharf Strategy Committee works hard to ensure the wharf to continues to provide safe access for our more than 80 community users including aquaculture, First Nations, fishers, governments and tourism.

Our digital booth was voted in the top five digital booths at Aqua Nor (81 registered booths in total). Our virtual booth attracted 376 visits and 2090 participants.




